MAJOR DUTIES:

- 1. Performs a variety of network device configuration and connectivity tasks.
- 2. Evaluates the performance of network devices such as servers, workstations, and peripheral devices, and remote access systems.
- 3. Implements procedures to ensure accurate records of authorized users of distributed software are maintained.

Performs other duties as assigned.

CONDITIONS OF EMPLOYMENT & NOTES:

- 1. Currently hold or be able to obtain a DoD 8570.01-M IAM Level 1 professional IT certification (i.e. CompTIA Sec+, Net+, A+; GIAC, CISM, etc.) within 6 months of employment.

- 3. May be required to successfully complete a probationary period.

QUALIFICATIONS:

GS-09: Your resume must demonstrate at least one year of specialized experience at or equivalent to the **GS-07** grade level or pay band in the Federal service or equivalent experience in the private or public sector. Specialized experience includes experience, education, or

training receiving, maintaining, and issuing data storage media for computer operations. Experience in scheduling the use of computer time for program processing. Experience collecting and sequentially staging input media with associated program instructions for processing. Experience in at least one programming language. Translating detailed logical steps developed by others into language codes that computers accept where this required understanding of procedures and limitations appropriate to use of a programming language. Experience interviewing subject-matter personnel to get facts regarding work processes and synthesizing the resulting data into charts showing information flow. Experience in analysis of the interrelationship of pertinent components of the system. Experience planning the sequence of actions necessary to accomplish the assignment. Experience scheduling the sequence of programs to be processed by computers where alternatives had to be weighed with a view to production efficiency.

GS-11: Your resume must demonstrate at least one year of specialized experience at or equivalent to the **GS-09** grade level or pay band in the Federal service or equivalent experience in the private or public sector. Specialized experience includes, education, or training that approaches techniques and requirements appropriate to an assigned computer applications area or computer specialty area in an organization. Experience planning the sequence of actions necessary to accomplish the assignment where this entailed coordination with others outside the organizational unit and development of project controls. Experience that required adaptations of guidelines or precedents to meet the needs of the assignment. Experience preparing documentation on cost/benefit studies where is involved summarizing the material and organizing it in a logical fashion.

<u>Substitution of Education for this GS-09 Position:</u> Must possess a master's degree or equivalent graduate degree or 2 full years of progressively higher level graduate education leading to a master's degree or equivalent graduate degree. <u>Substitution of Education for this GS-11 Position:</u> Must possess a Ph.D. or equivalent, or three years of progressively higher level graduate education in computer science, engineering, information science, information systems management, mathematics, operations research, statistics, or technology management **or** degree that provided a minimum of 24 semester hours in one or more of the fields identified above and required the development or adaptation of applications, systems or networks. (Note: You must attach a copy of your Official Transcripts.)
